Please be aware that as announced over the last several months, the ASCE St. Louis Section is proposing a Constitutional Amendment to consolidate positions within the Board of Directors. I also look forward to the opportunity to serve the Section in the next year as Past-President.

To all members of the St. Louis Section, and anyone considering membership in ASCE who happens to be reading this, I encourage you to renew your membership (or join) and get active in the Section and/or at the "Society" level. Section Constitution and Bylaws Proposed Revisions

The Board of Directors created a task committee to streamline the number of Board positions within the St. Louis Section. They have proposed elimination of the position of Vice-President and a reduction of one Director position. The following links show the changes to the constitution and the constitution marked up from the changes. https://sections.asce.org/st-louis/proposed-revisions-may-2022. These proposed revisions were posted to the Section website here and a link to these revisions were provided via the May mid-month update on May 9th.

As stated in the Constitution, these revisions are to be published for the membership to view for 30 days before the Board can vote on recommending these changes placed on the ballot. The Board plans on voting on these recommendations following this 30-day notification period. If the Board of Directors votes to approve these constitutional amendments, the next step is for the Section membership to vote on the amendments, at which time a ballot was distributed to membership via email about August 10, 2022 for voting. Please refer to that email for voting instructions. **Voting closes September 10, 2022.**

How to be an Effective Witness in a Legal Deposition Interview

In today's world, people and businesses involved in professional, commercial or industrial disagreements may seek resolution in a civil lawsuit. The great majority of such disagreements are resolved through negotiation prior to a formal (and expensive) court trial. Typically, that negotiation and trial preparation both rely heavily upon a serious investigation of the relevant facts of the dispute. A key part of that investigation is a formal interview of potential witnesses known as a deposition interview. Statements made in a deposition interview are taken under oath and are recorded. The person interviewed is actually providing legal testimony which may be used in a subsequent trial. As an engineer climbs the career ladder and increasingly takes on administrative responsibility, being required to participate in a deposition becomes a realistic possibility. It can be very helpful to have a basic understanding of the purpose and process of a deposition interview.

SPEAKER

David Flanagan, Civil engineer, PE

Judge David Flanagan is a civil engineer (PE, Wisconsin since 1971) who has participated in hundreds of deposition interviews and trials in which depositions were offered as evidence. He served 17 years as a Circuit Court Judge in Madison, Wisconsin and prior to that he was a trial attorney for the Wisconsin Attorney General for 24 years. As a trial attorney, he was responsible for criminal prosecutions as well as defending civil lawsuits, primarily professional negligence claims involving engineers, physicians and law enforcement officers. He received a degree in Civil Engineering from the Missouri School of Mines and a Law Degree from the University of Wisconsin Law School. He worked as an engineer for the Trane Corporation and spent three years as the Diving Officer focused on underwater construction for a Navy Seabee battalion. Judge Flanagan currently serves as a reserve judge in Madison on an as-needed basis, conducts mediations and represents clients in Veterans Affairs disability claims, pro bono.
